(hereinafter called "contracting parts") in their effort to:

- Establish ties of friendship and cooperation;
- Support and further develop the traditionally good relations between entities;
- Promote academic and private sector research exchanges (exchange of undergraduate and postgraduate students, faculty staff, summer programs) and the free flow of eligible information and research opportunities as designated by both;
- Promote mutual understanding, cultural, academic and public and private sector collaboration;
- Organize thematic meetings and conferences, development of joint programs, information and communication technology projects;
- Workshops, virtual meetings;
- Work toward more formal, complex and binding agreements;
- Strengthen friendship and good relations between both entities in representing the oral and general healthcare sector at large, and not limited to the aforementioned.

Commit themselves to the following articles of this Agreement:

### **Article 1.**

The contracting parties will encourage the development of bilateral relations between their affiliates network by supporting the following activities as agreed by both parties on a case by case basis and at will:

- a. Opportunities for visits and exchange of lecturers, medical experts and scientific workers;
- b. Exchange of students;
- c. Exchange of pedagogical methods and materials;
- d. Exchange of scientific information and publications;
- e. Joint scientific projects and meetings;
- f. Technical and educational upgrading of personnel.

## **Article 2.**

The cooperation activities will be carried out after mutual consultation between the various axes of interest and departments concerned. The activities will be carried out depending on the availability of existing funding and agreed at will on a case by case basis. The contracting parties will make efforts to raise the necessary funds to make this cooperation feasible once projects are identified and agreed upon.

## **Article 3.**

The cooperation according to this Agreement will be subjected to the legislative and judicial norms valid in the countries of the respective contracting parties.

## **Article 4.**

This Agreement will come into effect on the date of its signing for a period of five (5) years. The period of its validity may be extended by mutual consent.
