**Agreement of Cooperation
(Memorandum of Understanding)**

Between

(hereinafter called “contracting parts”) in their effort to:

- Establish ties of friendship and cooperation;
- Support and further develop the traditionally good relations between both Universities;
- Promote academic exchanges (exchange of undergraduate and postgraduate students, faculty staff, summer programs) and the free flow of information;
- Promote mutual understanding, cultural and academic collaboration;
- Organize thematic meetings and conferences, development of joint programs, information and communication technology projects;
- Workshops, virtual meetings;
- Work toward more formal, complex and binding agreements;
- Strengthen friendship and good relations between both countries

Commit themselves to the following articles of this Agreement:

Article 1.

The contracting parties will encourage the development of bilateral relations between their Universities by supporting the following activities:

- a. Visits and exchange of lecturers, medical experts and scientific workers;
- b. Exchange of students;
- c. Exchange of pedagogical methods and materials;
- d. Exchange of scientific information and publications;
- e. Joint scientific projects and meetings;
- f. Technical and educational upgrading of personnel.

Article 2.

The cooperation activities will be carried out after mutual consultation between the departments concerned. The activities will be carried out depending on the availability of existing funding. The contracting parties will make efforts to raise the necessary funds to make this cooperation feasible.

Article 3.

The cooperation according to this Agreement will be subjected to the legislative and judicial norms valid in the countries of the respective contracting parties.

Article 4.

This Agreement will come into effect on the date of its signing for a period of five (5) years. The period of its validity may be extended by mutual consent.
